Mayor Helen Smith-MacPhail called the meeting to order at 7:00 pm.

Mayor Report

- → In May, Mayor attended:
 - The Finance, Properties, Planning Board and Canada Day Celebration Committee meetings.
 - Afton Community Center's BOD meeting to follow up on the letter sent on June 20,
 2022, requesting the use of the entire downstairs area for the Municipality in the very near future.
 - Canada Day Celebration events She presented a summary of the event and the Memorial service for Elizabeth Wilson, followed by planting a tree at the Afton Community Center Memorial Garden.

CAO Report

→ On May 24, 2022, CAO Smith-MacPhail requested a New Enumeration List according to the RMWR's 6 Wards. Election PEI refused to provide the lists according to the new Wards. RMWR was informed that Election PEI could only supply the list to rural municipalities from the separate communities that make up the Rural Municipality of West River (Afton, Bonshaw, Meadow Bank, New Haven-Riverdale, and West River). This matter was referred to Municipal Affairs. Finally, on July 13, 2022, CAO Smith-MacPhail received a call from Election PEI informing her they would provide an Enumeration List according to the RMWR's 6 Wards and send it to RMWR by mid-October. The Information Sharing Agreement was signed and hand-delivered to Election PEI.

→ CAO Smith-MacPhail informed the Council that the president of Central Queens Wildlife

Federation requested to present at the next council meeting to discuss strategies to improve

coordination and communication with the councils to enhance the communities. The CAO was

directed to invite them to the next meeting in September.

• Finance Committee Report

→ Chair Stephen Gould noted the Committee met on July 5, 2022 and July 18, 2022. He presented a summary of the meeting's report.

• Planning Board Report

- → Councillor John Yeo noted the Committee met on June 13, 2022 and July 11, 2022. He presented a summary of the meeting's reports. and July 11
- → Following PLB18.5's recommendation, the Council approved that the Mayor would send a letter to the Minister of Fisheries & Communities and the Minister of Agriculture & Land and copying both MLAs and the PEIFM. It was moved by Councillor John Yeo and seconded by Deputy Mayor Robert Clow.

• Properties Committee Report

→ Chair Chad Stretch noted the Committee met on July 4, 2022, and presented a summary of the meeting's report.

• Canada Day Celebration Committee Report

→ Chair Robert Clow noted the Committee met on June 20, 2022 and presented a summary of the meetings' reports.

Other Business

→ A concern regarding the boat launching at the end of Westville Rd in New Dominion was brought to the RMWR's attention on June 26, 2022.

- Several Council members paid a site visit, and it was noted that a variety of people used the boat launch area with vehicles & trailers parking along the shoreline to access the West River via paddleboard, kayak and small watercraft.
- This issue was discussed at the June Planning Board Meeting (PLB18.6) and then brought forward to Council's monthly meeting in July.
- The responsibility for the access and activities would be under the Province's jurisdiction; road conditions would be the Department of Transportation and Infrastructure Highway Maintenance Division, and boating access would be the Department of Fisheries and Communities. The RMWR is not able to make changes or improvements to the situation.
- The Council concluded that although the RMWR has no authority to take action, they share some concerns. It was decided that the Planning Board Chair would send a letter to the Province to bring those concerns to their attention and also contact the concerned resident and suggest that he does the same.
